July 29, 99 Jerilyn

7-30-99-

Went to drive up window at bank
& forged her sister's name and stole \$500.
When sister found out (1 day later because
her passbook was missing) & I confronted
Jerilyn she wouldn't admit it until I
threatened her. She said she had to or she
would be dead & first admitted she
was using marijuana & cocaine. I followed
her to her room while she supposedly
looked for the sister's savings book in
2 different drawers & said she couldn't
remember where she put it. While
I called someone in the Sheriff's Dept.
& then Soc. Serv. she then started scratching
at her wrist (while her Dad was watching
& keeping her in her room so she wouldn't
run off or whatever else she might do) with
a scissors. When he took that away
she used a pen to try to poke at her wrist.
After telling Soc. Serv. to call the police
& going into her bedroom she picked up
an already straightened out big paper clip
& started to poke at her wrist. I got on
top of her (she was laying on the floor)
to get the paper clip away because she
wouldn't give it to me & she threw it
off then.

7/30/99

When the police arrived she also admitted to them that she had done "skrooms" (mushrooms) once or twice. The police took her into Norwood. On Sunday when we went to see her (Mr Dad's) she still had a very negative attitude towards us, or me anyway. When I asked her if she had been doing any thinking she said if that's all we came for she wasn't going to talk to us & looked off a different way & stared off that way.

She ~~still~~ still won't say who has the sister's savings book. She told the police when they picked her up that it was at someone else's place but won't say where.


I also wouldn't let her go into town 7/29 (she said to the Rootbeer stand) with Jack Curry (her "boyfriend"), Jake Harvelson, both of Dorchester, and another boy who showed up here. 10 min. after they left she said she was going on a walk. That is when she met up with the 3 boys down the road & went to steal the money from her sister.

She also was still lying to me on 7/30 before we called the police when she supposedly was looking for the savings book in her

drawers knowing very well that it wasn't there. She still has not apologized to her sister.

A few weeks ago at about 10:30 p.m. when we wouldn't let her watch the night time comedy shows & told her to go to bed she refused & kept refusing & getting angrier at us. She wanted to "leave" or go by a friend's house get at that time. Her Dad said we'd take her into Norwood at that time. She was sitting on the couch & so angry about the whole incident she wouldn't move. When her Dad tried to take her hand to get her up & take her in to Norwood she kicked him in the groin so hard he went into Medford hosp. ER because it hurt so bad. He told the ER people at the time that a horse kicked him. & Even while he was gone she kept telling me she wanted to go to a friend's house yet that night. She didn't even care to find out if her Dad was okay or say she was sorry, she just wanted to leave.

She had also told her sister's boyfriend a few weeks ago that her and Robert Peterson (Medford) a guy she

liked since about December '98, ^{to May '99} had
had sex. ~~The boyfriend to her~~ The sister's
boyfriend to Nicole; she talked to Jerilyn
& then told me that Jerilyn had been
having sex with Robert. 

The Friday Jerilyn went into Norwood
before the police came she also said it
was Robert who had gotten her going on
drugs. — Just as another note —

Robert was always very polite to us,
even went with Jerilyn to visit her grandparents
next door. I knew he had been in "some kind of
trouble" before involving a stolen vehicle which
he said he didn't do but was along when
the police got the vehicle. He had to
pay some fine (that his parents couldn't afford
to help with supposedly because they had just
put up a garage) or he would go to jail.
I loaned him \$1500.00 & haven't seen
any repayment at all yet. (Shows how
gullible & stupid I am.) She told John
Mary that she won't testify against Robert.

Also on the Sunday evening she was
still in Norwood I checked under my
mattress where I kept some cash to find
she had taken it all. On the outside

of the envelope I had written \$11.90-.
At one point when I wondered what was
going on I wrote \$7.50- on the inside of
the flap (a couple of weeks before) because
that was all that was in there. When
I realized it was gone & asked her, she
admitted to taking it.

Her Dad also had about \$300
taken from his wallet while he showered
in January. There was a cousin of
Jenilyn's here at the time & we couldn't
figure out who took it. They both
denied it & the cousin ~~is~~ has also had
her problems so we didn't know who
had taken it.

Her Dad had also had some money
taken from his drawer in our bedroom at
different times. He isn't sure how much
(\$100.00 or so). He no longer keeps money
there.

On one other occasion several months
ago I had a tin can with probably \$10.00
worth of change in it & it all disappeared.

I believe she also has taken money
from my purse at times.

Our family also had collected the money gathered at our family reunion. She helped me count it. It was \$256. After all this, Nowood & such took place & she admitted to stealing my money from under my bed. She also admitted to stealing the reunion money. Before that 2 kids had rode bikes here one day from town. When I found the money missing (within 2-3 days) she tried to say they must have taken it. She said they were trouble. I told her they couldn't come here again & she said okay. We even had told Conrad Christensen, the psychologist we've been seeing since May, about the incident. ~~Not~~ knowing she had done it & talked of setting a trap & she never admitted to doing it.

about 1st of
January

She had gotten a job at the Owen Golf course bussing tables etc. on Friday evenings & occasionally Saturday evening or Sunday. I told her she could start paying me back. She had every excuse to not pay me if from, than for prom, went shopping, I didn't get money except a few dollars

She won't admit Jack Curry & Jake Harrison do drugs. 2 other teenagers believe this is a lie. One said she saw a bunch of the these kids all go into a ~~bedroom~~ bathroom for 20 minutes together. The other kid saw Jack & Jake separate, line up & sniff cocaine. Jerilyn had rudely told this kid to take her to Dorchester. She had told us they were going deer skinning. Come to find out the lights in the car they used didn't work so they couldn't chase deer with it. She wouldn't admit to me when she went until I told her I had talked with Jack (he had called to talk to her) & he said she was over there the night before.

I ~~took~~ took all the phones out of her reach in the house about 3 weeks ago when when she refused to quit making long distance calls, \$117⁰⁰ on the last bill, \$89 on the month before & at least \$40 plus on the last several months bills. She had started working doing

barn chores next door in June but
after 1½ wks had all kinds of excuses
to not go to work. The guy (another
cousin of hers) kept letting her
show up when she wanted but she
got so she wouldn't go at all.

She also kept stealing cigarettes
from his truck. She did give me
2 checks from him, one \$111 + one \$89 to
cover some phone bills. When she
quit going to work I refused to let
her use the phone. Come to find out
she got a hold of a different small
phone + would use it at night when
we went to bed. She also has
been using my cellular phone for
the last 3 months. My bill is usually
\$240 or so. One month it was \$80 + I
just wondered why. The next month it
was \$89 I believe + this last one was
\$110⁰⁰. After we started to put all
the pieces together + I questioned
her on this she said she didn't
use it that much. She also went to
the cousin's barn next door + Grandpa's to
place the other way + used their phones, including
some longer distance. They no longer let her use the phone.

The cousin next door takes the phone with when he is not there now. He shouldn't have to do this.

For the last several months when given jobs to do at home she would only do what she wanted to whenever she wanted to do them. Some days she would do things & some days there was no way.

I have even asked her if she wanted to do some office work for me because I work from my home a lot & she could help me. Before Christmas she made \$95 @ \$5/hr for some presents. But she never even paid her sister (Amy) for some gifts ~~the~~ our girls went in on together or what Amy paid for thinking Jeryllyn would pay her back. I finally gave Amy the money (\$56 I think) so she wouldn't be out it. Our girls (we have 4 girls) also went together to get us a grill for Mother's & Father's Day '99. Jeryllyn never paid Amy for that either.

Last summer (98) she had been
babysitting for a family ^{for one} weekend.
They took her with them to visit relatives
in a suburb (I can't recall for sure but
think it was Milwaukee). She was supposed
to babysit while they went out. She
proceeded to steal 5 rings & a pair of
tennis shoes (that didn't even fit her). She
wouldn't admit to us she had done it.
This couple finally got her to admit
she took 3 rings & she gave them & the
shoes back. She kept denying the other
rings until they talked to her again
& then she admitted to throwing them
out the car window when going somewhere
with some cousins. She also finally
admitted to stealing some expensive
make-up brushes from the people she
babysat for. I paid \$300 for the 2 rings
& \$100.00 for the brushes to keep her from
being turned in at that time. I told her
she could get a job & pay me back.
She also had a cousin come babysit
with her at this place & tried to blame the
cousin for the brushes for a long time,
until she finally admitted she took them.

People used to call for babysitters.
She has refused for last 8-15 months
saying that the kids are brats. I've
told her she could babysit to make money.
She doesn't care.

She could also do some house cleaning
for her Grandma next door to make some
money. She refuses.

She "takes" whatever she wants.
Her sister (Nicole) has had to put a padlock
on her door for the last 2 years.

She takes whatever food especially
junk, or goodie type food she wants
without asking. We cannot have pop,
gum, pizzas, chips, etc around just
to have on hand for company or treats. She
just takes it. 2 weeks ago I had
a package of 10 carnal nut candies in the
cupboard. She actually "asked" if she
could have some. I said no. The next day
she took the whole pack to her room & ate
them. When I asked her about them
she said she thought I only meant she
couldn't have them the evening she asked.
She ate the whole pack. She takes all the

hairspray, make up, clothes of others from the wash, lighters (we couldn't even burn the garbage), clothes & jewelry from friends (except the borrows, but won't return).

Her tendons & ligaments are too stretched. I've taken her to doctors, physical therapists & a chiropractor many times for treatments. She cannot sit for really long or run much because it makes her hurt. The chiropractor, who does a lot with nutrition, very much encouraged vitamin supplements specific for tendon/ligament help & protein & recommended 2 eggs a day for protein. She ^{now} refuses all of that (did take the supplements for awhile) but just wants to go to the chiropractor for adjustments. I told her it doesn't pay to do the adjustments if she won't take the vitamins, she won't take them.

She flunked several classes in 9th grade this year at public school. She also spent 5th, 6th grades at a private school, where she did very well grade wise, 7th & 1st quarter of 8th at public school where she claimed she couldn't deal with it the rest of 8th was back at private school.

For 9th grade she went back to public because she wanted office classes & sports.

The school was going to let her go out for track in the spring (she is fast but hurts herself) & keep track of her grades. She wouldn't do the warmups right I believe & wouldn't take the supplements & vitamins & got hurt in the 1st week. That was that.

She won't tell the police who the drug dealer is or how she gets them.

She won't say when her sisters Savings book is.

She "lost" the house key & took her sisters & I believe doesn't have that one either. Her dad changed the whole lock now.

She has gotten 4 tattoos since summer & won't say from who. & refuses to get them removed. She has 1/2 of a tattoo for KORN a group who is the #1 Devil worship group who says in their literature etc that they are out to win souls for the Devil.

Rebels at anything I try to tell her or explain to her. Acts rude or indifferent toward him. Tells me she doesn't want to see him.

Her bedroom is usually a disaster & says it's her room. Her Dad & I cleaned it & took away all of the clothes with rude or derogatory writing or too sexy or small for her but she would wear anyway. We also took the condoms from her billfold & throwaway things with vulgar/disgusting writing on it. We did this while she was at Norwood. She claims we owe her \$500⁰⁰ for her clothes etc. ~~There~~ No way. It ~~would~~ wouldn't have come to nearly that.

When she went to stay supposedly at 2 ^(T.W.) girls house in Dorchester the ~~same~~ night of July 22 she wouldn't come home Friday night & later admitted she spent the night alone in Dorchester Park. She was supposed to be with a G cousin (Brandon Klemetsen who is currently seeing Josh Curry's brother Brian). They went to Moxie Hall

by Unity. Amanda had to go home to get
sleep for work. Jeryllyn says she was with
Josh, Jake & some other people & told Amanda
she'd have them take her home. She says
she just walked off & spent the night
in the Park. On Saturday I called ~~Josh's~~ Amanda's
place to find out she was at Josh's place.
Her Dad & I went there & she refused to come
home. She said she needed time to think
& was going to church with Amanda. On
Sunday we found out she didn't go to church.
She said there wasn't time after we
were there. We left at 7pm. Church didn't
start until 8pm. I had told Josh's mother
that Jeryllyn could not stay there. Sunday
evening about 10pm we went to Josh's place
again to find her there. I told her if she
didn't come home right then that I would
press charges against his parents for
allowing her to stay when I had told
her she couldn't. She nastily came home
& said she had stayed at a trailer next
door where they have a teenage girl.
When she came home she was belligerent
& when her (3:00pm) came she refused to
turn off the TV. Her sister upstairs & we
in our room could hear it yet. Her Dad got up
& cut the cord off the TV.
