Details: it about 33 op.m today jicall (our 19 yo dau) called to say Cheryl had taken \$500 - out of her savings acct by using her passbook & forging her name. I confronted her & she finally admitted that she "had to" I'd be dead by now". After pressing her what she did with it she said she has a drug problem she wouldn't say what she did with the money except she gave it to a dealer. She said he lives in town with her but wouldn't say any more. She says how she hates me and doesn't want to live here & was going to leave but we wouldn't let her. She was trying to scratch on her wrists with an open scissor while I was talking to the police social worker (after talking to the police). She also opened up a large paper clip to try to scratch her wrists which she threw away only after I came on top of her to forcefully try to get it.

She had also admitted to her sister (Nicole) 2-3 wks ago that she had had sex with Robert Peterson (Madford) who she liked from about 11-98 or so. She also said this is who she got on drugs with. She verbally said she wants to die about 3 times.

GIRLS STOPPED AND WE DROPPED TIFFANY OFF AND I GOT INTO THE FRONT SEAT AND WE TOOK JERICYN HOME. I DIDN'T REACH DEGRASS.

ON OR AROUND JANUARY 1, 1999 I AND DAN SCHWARTZ AND JERICYN DROVE TO ILLINOIS TO VISIT RELATIVES. WE DROVE DOWN IN MY RED 1984 FORD VAN. ~~RP~~ ~~RP~~ ~~RP~~ I DIDN'T SHOW DAN ANY GUN BEFORE WE LEFT. ON THE WAY TO ILLINOIS DAN OR I DIDN'T SHOW JERICYN ~~RP~~ ^{RP ANY} GUN. WE GOT LOST & STOPPED TO ASK A COP FOR DIRECTIONS. THE COPS ENDED UP SEARCHING THE VAN WITH MY PERMISSION. THEY FOUND A GUN IN THE VAN. I DON'T KNOW WHERE IT WAS. THEY SHOWED ME THE GUN AND I RECOGNIZED IT AS TERRY THOMAS' GUN. TERRY WAS MY UNCLE. I THINK THAT DANNY MAY HAVE PUT THE GUN IN THE VAN. I KNEW THE GUN WAS TERRY'S BECAUSE I KNEW THE MY BROTHER EDDY WAS HOLDING ONTO THE GUN FOR TERRY. "ROAD HEAD" HE MEANT ORAL SEX. I TOLD HIM I DIDN'T WANT TO. HE UNZIPPED HIS PANTS. I WAS SMOKING A CIGARETTE VERY SLOWLY BECAUSE I KNEW I WOULDN'T HAVE TO GIVE HIM ORAL SEX AS LONG AS I WAS SMOKING. WHEN I WAS DONE SMOKING, HE GRABBED ME ON EACH SIDE OF MY FACE AND FORCED MY HEAD DOWN. HE WAS FORCING MY HEAD UP AND DOWN AND I HAD HIS PENIS IN MY MOUTH. THIS WENT ON FOR ABOUT 10-15 MINUTES. WHEN WE GOT TO OWEN HE STOPPED. HE DID NOT REACH ORGASM. HE LEFT ME IN THE BACK SEAT AND HE JUMPED IN THE FRONT SEAT.
