



I was surprised to receive your letter of August 18, 2003. I was unaware of the filing of this motion.

The problem is that the motion was sent to and filed with the clerk. No copy was ever sent to my office. Further, because the file is closed, the case does not show up as "pending" in the CCAP records. A post-conviction motion does not convert a closed case into a pending case. And the clerk's duties are to file the document, not to review it and transmit it on to other people.

Moral of the story: *For future reference, always send a copy of a post-conviction motion directly to the assigned judge as well as file the original with the clerk.*

In order to give the district attorney an opportunity to respond to your motion, I would appreciate your seeking an extension from the Court of Appeals.

By this letter to the district attorney I am requesting that he file any brief in opposition no later than September 5, 2003. My judicial assistant will be contacting counsel to schedule a decision date shortly thereafter.

**MOTION FOR EXTENSION OF TIME IN WHICH CIRCUIT COURT
MAY DECIDE POSTCONVICTION MOTION**

Defendant, Robert L. Peterson (Peterson), by his attorneys Kohler & Hart, LLP, by Martin E. Kohler, and Donald J. Chewning, hereby moves the Wisconsin Court of Appeals, District III, for an order extending the time in which the Taylor County Circuit Court, Judge Gary C. Carlson presiding, may decide Peterson's postconviction motion. This motion is brought pursuant to Wis. Stat. (Rule) § 809.30(2)(i). Peterson requests that an additional 60 days from the date of this filing in which the circuit court may issue an order deciding the motion. As grounds for this motion, Peterson states as follows:

1. On July 2, 2003, Peterson timely filed a Motion for Postconviction Relief in the circuit court pursuant to Wis. Stat. (Rule) § 809.30. Currently, the 60-day period in which postconviction motion must be decided expires on September 2, 2003.
2. As of August 18, 2003, no action had been taken on Peterson's motion. Accordingly, Peterson wrote to the circuit court regarding the matter. In


response, the circuit court informed Peterson that it had not been made aware of the postconviction motion by the Taylor County clerk of courts, and asked that a motion be filed requesting more time in which to file the motion. A copy of the letter written by the circuit court to Peterson's counsel is attached. Given the fact that the Court only recently became aware of the motion, an additional 60 days from today's date would be appropriate. Peterson thus requests that the time by which the circuit court must decide the motion be extended to October 20, 2003.

3. Pursuant to Wis. Stat. (Rule) § 809.30(2)(i) and the circuit court's request, it is the defendant's obligation to request an extension from this Court.

WHEREFORE Peterson respectfully requests that the Court extend the time in which the circuit court may decide Peterson's postconviction motion an additional 60 days to October 20, 2003.
